The EU accounts for about 50% of total world imports of bed, table, toilet and kitchen linen (SITC3: 658.4). Among the suppliers to the EU, the market share of non-EU countries was 63.2% in value and 69.8% in quantity in 1997. During the period under review, the following non-EU suppliers had a significant growth in the value of their exports with a trend of 26.5% for Egypt, 22.5% for Turkey and 19.9% for Poland. The trend of the value of Romanian and Estonian exports was 30.5% and 23.7% respectively, although their market share was 0.7% and 0.6%. Germany was the largest EU import market in 1997 and accounted for 32% of the total value of EU imports. It was followed by the United Kingdom, France and the Netherlands. These three countries accounted for 40% of the total value of EU imports.

Annex II gives statistical details on EU imports of linen, by category of products.

## **Market characteristics**

Purchases of low quality linen products have been declining during recent years, whereas medium quality items are more and more preferred by consumers. Their buying attitude focuses on colour and design, prices and cleaning conditions. The trend in the last few years has been for bright colours and a large variety of patterns.

The most important development concerning bed linen in latter years has been the introduction of the eiderdown, also referred to as duvet or quilt. Several types of bed linen are marketed; they are, in decreasing order of importance: flat (non-raised), jersey, terry, flannelette and seersucker. Demand for king size bed linen (2,40 x 2,60 or 2,80 cm) is growing for children as well as for adults. Prints are the most popular for quilts, but single colours are preferred for sheets. For children, designs are mainly Walt Disney's heroes and cartoon characters. The average time between two purchases of bed linen is 3-4 years and retailers are trying to encourage consumers to replace their linen more often.

For table linen, the trend is for easy to clean products. For daily use, consumers prefer bright colours whereas for festive days they prefer more traditional table linen whether embroidered or not, with white or pastel colours.

Kitchen linen is divided in two types: hand towels made of terry or flat woven and dish towels made only of flat woven.

Hand and bath linen items purchased are mainly terry towels. The trend in bath towel purchases is for good quality products of a weight of 500-540 g/sq.m.; cheaper qualities weigh 300g/sq.m. As for bed linen, demand for king size items is growing with, for example, bath towels of 90 x 150 cm. Main consumers are households, hotels and hospitals. Because of the necessity of regular washing, quality and colour fastness are important.

### General specifications for terry towels:

A good quality towel has a weight of at least 400 g/sq.m.:  
warp: Ne 30/2; loop: Ne 20/2; weft: Ne 16/1

A cheaper quality towel has a weight of 300 g/sq.m.:  
warp: Ne 16/1; loop: Ne 16/1; weft: Ne 16/1

Most common towel sizes are as follows (in cm):

Hand towels	: 50 x 90-100; 55 x 110; 60 x 120
Bath and beach towels	: 60 x 180; 70 x 130; 75 x 150; 80 x 140; 90 x 150; 90 x 170; 100 x 150-170; 140 x 160
Guest towels	: 40 x 60
Washing gloves	: 15 x 20

Sizes and weights of linen articles vary from one country to another, they are generally specified by the importers in their purchasing orders. In addition, importers can provide information on, for example, patterns design, labelling, packaging, delivery schedules, etc. (See in annex I sample contracts for bed linen and terry towels).

## Market access

### Tariffs

Duty rates levied in the EU are 12% ad valorem at the exception of the following HS headings for which the rates are 6.9% :

6302.22.10	Bed linen, knitted or crocheted, of man-made fibers, non-woven

Imports from developing countries are regulated by the following conventions :

- ***Agreement on Textiles and Clothing (ATC)***: following the conclusion of the Uruguay Round, the ATC, which replaced the Multi-Fibre Arrangement (MFA), will last for a transitional period of ten years. In January 2005, the sector will be integrated into the rules of the WTO, and it will not be possible for any member country to maintain quantitative restrictions on imports of textiles and clothing, unless it can justify them under the safeguard provisions covered by the Agreement. Duty rates will remain, even though they will continue to be regularly reduced over the transition period.
- ***New Generalized System of Preferences (GSP)***: A new multinational scheme of GSP came into effect in January 1999 and will be applicable for three years. For textiles and clothing, the preferential duty is 85 % of the Common Customs Tariff. Least developed countries (LDCs) are exempt and benefit from duty-free and quota-free imports. African, Caribbean and Pacific (ACP) countries benefit also from duty-free and quota-free imports under the ***Lomé Convention***. In addition to LDCs and ACP countries, Bolivia, Costa Rica, Ecuador, El Salvador, Guatemala, Honduras, Nicaragua, Panama, Peru and Venezuela are exempt as a result of their commitment to combat drugs, on condition that they comply with and monitor environmental protection and labour rights. The Common Customs Tariff may be reintroduced if evidence is found of slavery, export of goods made by prison labour, money laundering, fraud and unfair trading practices.

To profit from preferential rates, goods must be accompanied by a certificate of origin (document issued by the authority in the exporting country to certify that the products are produced or manufactured in an ACP country). The definition of the origin is particularly important in the case of two or more countries being involved in the production of a product and having different access conditions into the European Union. The Rules of Origin fall under a detailed regulation enacted by the European Commission. In general terms, the process undertaken by a country is considered as sufficient to confer the certificate of origin of that country, if it has resulted in a change of tariff classification in the Harmonized System Nomenclature between the input and the processed exported product. The certificate is issued by a competent authority in the exporting country.

### **Regulations**

There is a growing awareness of the need for environmental protection in Europe, especially in Germany. This is due partly to the world trend towards nature and health. This trend is used by companies to build a brand and an image, both in the company's advertising and in the message on eco-labels.

Natural fibres, including cotton, are affected by these initiatives. The production of synthetic fibres is increasing because the latest technological developments often show no disadvantages and sometimes even advantages in a comparable eco-balance sheet over a natural product.

In Germany, some synthetic materials such as certain Azo dyes which are considered to be carcinogenic have been forbidden in imported textiles (see annex III on banned azo dyes). Any product found containing these substances will either be returned to the supplier or burned. Not complying with these requirements could cause a jail sentence of up to three years. A similar regulation was effective from the second half of 1996 in the Netherlands.

While the German Ordinance applies to "any article which is intended to come in contact with the human body on a frequent basis" the Netherlands Regulation is more specific and concerns only clothing, footwear and bed linen. It is the responsibility of the importers to comply with this regulation. Other EU countries are expected to follow and a proposal for a European Union regulation is under preparation.

### **Distribution channels**

There are three main categories of importers of household linen. They include specialized importers/wholesalers, large department stores and mail-order houses (see list of selected importers in annex VI).

At the retail level, supermarkets and hypermarkets have a leading share of the household linen market (around 35%), followed by mail order houses (around 30%). While mail order houses dominate the bed linen market, supermarkets and hypermarkets dominate the toilet linen market, mainly composed of terry towels.

Mid to low-quality linen are mainly distributed through chain stores and department stores as well as mail order houses. High-quality products are sold in specialized stores such as home furnishing retailers.

Import Promotion Offices established to assist developing countries and some national trade promotion organizations offer among other services, lists of importers, wholesalers, distributors, etc., and assistance in establishing contacts particularly through publication of product offers (see useful addresses, annex IV).

### **Packaging and labelling**

Linen items are generally displayed vertically and hung on pegs. This requires a very resistant packaging which generally consists of plastic bags. Each article must be labeled with information on size, material composition and washing instructions. In the case of a large printed pattern, it is advisable to include a photographic reproduction.

Expensive items are packed in presentation cartons with a cellophane-covered window to view the design. These cartons are in colour printed card on the exterior, with a white interior and the usual labelling and product description.

### **Commercial practices and sales promotion**

Overseas suppliers are usually paid by Letters of Credit. Delivery time is negotiable between exporters and importers; it is more flexible than for garments where delivery time is more important as fashion changes rapidly. Once a delivery time is agreed upon, failure to meet it may result in cancellation of the order.

Specialized European trade fairs enable traders to establish contacts, promote sales and keep up to date with the latest trends and developments in fashion and design. In addition, advertisements can be placed in specialized revues on interior decoration and home furnishings. (See list of trade fairs and specialized publications in annex V)

At the retail level, supermarkets and hypermarkets are using more frequently the concept of proximity of articles where household linens are displayed together with crockery and electric domestic appliances. Another option consists of displaying household linen next to ladies' ready-made garments to incite impulsive buys.

### **Market opportunities**

With a growing emphasis on improving home interiors, the market outlook for household linen is expected to remain stable. The average European consumer demands a wide range of good quality items. As high to medium quality linen products are produced in Europe, mid to low-range articles present the best sales prospects for exporters from developing countries, who can offer good quality articles with competitively low prices.

Special care should be taken regarding delivery schedules, consistent quality, and attention should be paid to packaging, which has to be attractive.
