1. PRODUCT DESCRIPTION

The market research file includes window coverings, classified according to the Harmonized System, under the following codes:

6303	Curtains, including drapes and interior blinds; curtain or bed valances of all types of textile materials (excluding awnings and sunblinds)
	Knitted or crocheted:

The heading includes:

- 1) Curtains (including drapes), which are used, for example, inside windows or to close recesses, theatre stages, etc. The expression “curtains” covers lightweight and transparent or semi-transparent articles and articles made of thick fabrics.
- 2) Interior blinds, which are usually opaque and of the roller variety (e.g., those for railway carriages).
- 3) Curtain valances (or pelmets), which consist of strips of fabric designed to be fitted above windows to hide the tops of curtains, and bed valances for attachment to beds for concealment and decoration.

The heading also covers material in the length so processed after weaving that it is clearly suitable for conversion, by a minor operation, into finished articles of this heading (e.g., fabric in the length to one edge of which has been added a frilled border and which, by simply cutting to required lengths and hemming, is converted into curtains).

Window coverings are used for various reasons, some of which are: to keep out light during the day, provide privacy and insulation (reduces noise and help keep out the heat and cold) as well as for decorative purposes. Curtains and draperies are made from different fibres and fabrics according to the purpose they need to serve. Some window coverings, most frequently used, are:

- Draperies, which are generally made of heavy fabrics, such as velvet, satin and jacquard. They usually have a lining and are hung from hooks.
- Curtains are lightweight, unlined and have a casing or a pocket for the rod, often used together with draperies. Materials used for curtains are casements, open weaves and prints.
- Lace or net curtains keep out the sunlight during the day but provide very little privacy at night. They are used more for adornment and are normally made of polyester filament, polyester stape and acrylic stape.

- Shades, are a soft covering, take less space than curtains and draperies and come in fabric and a variety of other materials.
- Blinds are similar to shades and are generally made of vinyl, fabric or wood. They can be either horizontal or vertical and can be adjusted to regulate the amount of light during the day and give privacy during the night.

This market research file covers window treatments made of textiles.

2. MARKET OVERVIEW

Curtains play an important role in home decor. Fashionable or functional, formal or casual, the style of window coverings can set tone and personality to a home. From classical French pleated drapery to bold contemporary prints and lacquered decorative poles, the choice depends on the style of the rooms, paints and the wallpaper.

The market for window coverings depends on the current trends in interior decoration, though fashions in furnishing fabrics are not as volatile as they are in the clothing sector and can remain in style for as long as four to five years. Curtain sales are seasonal with a large percentage of the sales in summer or autumn. According to the CBI study on Household and furnishing textiles, approximately 30% of sales in curtain material are where there is a shift in residence - individuals buy new furnishings when they move houses.

Pleated drapes seem to be back in fashion, with a wide range in the type of pleats. In this case, the materials used vary from satins and jacquards to sheers and other lightweights. Pleated curtains are often combined with swags or trims to enhance the decor of a room. Rich velvet valences together with the drapes add a Victorian touch, while prints are used to give a more casual look. Sheers and lace curtains serve as an embellishment more than anything else; sheers are sometimes combined with drapes to give a formal look.

Although curtains are made of different materials, synthetic fabrics combined with pure fibres dominate the market for curtains. This is because, synthetic fabrics are not only relatively inexpensive, but also easy to maintain. Fabrics such as cotton are inexpensive, but involve laborious cleaning procedures. Expensive materials like silk are also used, though less frequently. In recent years, flame retardant fabrics have begun to gain ground and in certain countries such as the United Kingdom, this has become an essential criterion for furnishing fabrics.

Curtain materials have two markets consisting of curtain manufacturers importing fabrics for their production and, over-the-counter trade of material. Curtains are also sold in ready-made lengths that fit standard window sizes. In recent years, custom-made curtains are becoming popular, despite their high costs, as individuals are looking for originality and want to be able to add a personal touch to their homes. Offices, hotels and other public places often resort to interior decorators to have their curtains custom made.

3. IMPORTS

3.1 World

World trade in curtains has seen considerable growth during the period 1993-1997. In 1996, imports amounted to approximately US\$ 800 million, which is a 60% increase from 1993. For reasons of comparison, data (from the database Comtrade) for 1997 has not been considered as they were incomplete at the time of preparation of this file. However preliminary figures indicate there was an increase in the world's two leading markets, the European Union and the United States, in terms of both, value and quantity.

According to trade sources, the market for household and furnishing textiles has been rather slow as a result of a sluggish economy. Buying patterns in the household-textiles sector is directly related to consumer spending behavior and as demand for these products is income-elastic, customers were reluctant to spend money to modify their interiors according to the current fashions. This tendency is, nevertheless, changing as the economy showing signs of revival, thus resulting in an increase in the purchasing power; lifestyles are beginning to alter, people are becoming conscious and are giving more importance to their homes.

In 1997, the European Union was the largest importer of curtains/drapes/blinds, followed by the United States, Japan and Canada (Table 1).

Trade sources indicate that global fabric production has fallen (1.3% in 1997) mainly due to a 6.9% drop in Asian production. However, stocks in fabrics have been on the rise in Japan (8.8%), the United States (3.1%) and Europe (1%), while stocks in Pakistan fell by 23% due to the strong demand from other Asian markets.

The principal suppliers include China, Turkey and Germany. The share of developing countries and LDCs is rather small, other than for Pakistan who ranked fifth in 1997, in terms of value (Table 2).

EU trade in curtains has progressed considerably over the past few years. Decline in EU production accompanied by a stable demand and a resurgence in the economy, resulted in a rise in imports. During the period 1993-1997, imports increased by approximately 154% in terms of quantity and 106% in terms of value. Exports grew by 24% in terms of quantity and 32% in terms of value.

Intra-EU trade in textiles and clothing has been substantial. Member States together are able to satisfy almost half (38% in 1997) of their requirements of textiles from trade between themselves and import the rest from third countries. Over the five-year period, both, arrivals and expeditions grew by approximately 86% each, in terms of quantity, and 80% each in terms of value (Table 3).

Although EU production statistics are not available, according to trade sources, Spain, Belgium, Italy and France are the largest producers of fabrics in the EU. Domestic production, together with imports satisfy EU demand for curtains. In 1997, EU was the largest importer of curtains in the world with 34,556 metric tons valued at approximately ECU 383 million. Germany was the largest importer with 10,394 tons, accounting for 32% of EU imports, followed by the United Kingdom (20%), France (10.6%) and the Netherlands (10.4%) (Annex I).

The major extra-EU suppliers of curtains were Pakistan with 4,032 tons (18.7%) followed by the Czech Republic (17.9%), India (13.5%), Turkey (11.6%) and Poland (7.5%).

The principal intra-EU suppliers included Germany with 2,811 tons, accounting for 21.6%, followed by Belgium-Luxembourg (12.5%), the Netherlands (10.4%) and Sweden (10%).

In 1997, the main category of imports was HS 6303.91 (curtains, of cotton, excluding knitted/crocheted), accounting for 38.9% of total EU imports followed by the category HS 6303.92 (curtains, of synthetic fibres), that accounted for about 30% of imports (Annex I).

Annex II gives EU imports of curtains, by product and by country.

4. DISTRIBUTION CHANNELS

Successful entry in the market depends on the selection of the distribution channels and the development of a good relationship between the supplier and the local agent. The most frequently used distribution channels in the textile trade are importers, wholesalers and agents. Importers are, by far, the safest and the best method for new exporters. They are well informed about the local market and help the supplier with the various administrative procedures involved in exporting. They also import, stock and distribute throughout the country according to the demand.

Once the quality of the product has been established and when they are familiar with the import market, exporters often resort to agents. However, in this case, exporters have to bear in mind that active participation from their side is necessary.

In the retail sector, independent retailers, department stores, mail-order houses, textile supermarkets, furniture and furnishing chains and supermarkets import either directly from the supplier or go through local agents. Sales agents do not sell directly to the potential customer; they present samples, secure orders and forward these to the exporters.

Specialized and independent retailers generally sell mid-high priced products while department stores and textile supermarkets cater to the demands for low-priced products, where quality is not an essential criterion. Annex V gives a list of importers/wholesalers and agents.

5. PRICES

Retail prices of curtains and curtain material depend on various factors such as quality of the fabric, country of origin of articles, rate of currency exchange, agents' commission, rate of duty, wholesalers' margin (20%-30%), retailers' margin (54%-78%), handling charges (transport, insurance, banking), value added tax, economic conditions in the country, volume of business, degree of risk, etc. Prices are also influenced by the demand and supply situation of fabrics. They are generally quoted CIF and suppliers are advised to check the local prices before exporting.

The following are approximate prices of curtain fabrics observed in a furnishing store in France. Prices of sheers vary between 50 FF and 225 FF, depending on the material and type of weave. Prices of other materials are given below and are in French Francs per metre. They vary between 200 FF and 670 FF depending on the kind of material and width (usually 140cm and 280 cm).

The prices of polyester fabrics sold under brand names, notably Pierre Cardin, are 336 FF and 671 FF, while for a pair of ready-made curtains, the cost is between 600 and 900 FF.

6. COMMERCIAL PRACTICES

Letters of credit are the most common method of payment used. This form of payment is recommended particularly when selling to a new or small importer or distributor. For larger firms or when there exists an established buyer-seller relationship, sight drafts are used. Large department stores or buying cooperatives might prefer open accounts. Cash against documents or extended credit terms of about 30-60 days are used in certain cases. Credit checks are recommended before entering into any business relationship.

Suppliers must make sure that the fabrics are of good quality, correspond to the samples and maintain delivery schedules.

7 MARKET ACCESS

7.1 Regulations, quality standards and packaging

The most important specifications to be considered while exporting are the technical requirements, quality of the product and the packaging.

Fabrics used for curtains are often synthetics. The fabric is accepted once the strength of the material has been tested. Some of the other criteria to be considered include the weight, type of weave, uniformity, burning behavior, toxicity, colour fastness, the effects of washing, staining, heat and light, and durability. Methods of bleaching other than that specified are acceptable if the submitted standards of whiteness are obtained. Type of weave is yet another important factor concerning quality. If major faults are found, the fabric cannot be sold and is automatically classified as damaged. Acceptable quality level (AQL) systems for the purpose of quality control are utilized throughout the textile industry.

CEN's TC 248 has been charged with considering the safety of curtains, draperies and bedding articles. CEN has already developed tests for curtains and draperies on ignition and flame spread which have been adopted by ISO (ISO 6940 : 1984 and ISO 6941 : 1984). So far

the tests have not been conclusive and additional trials have to be carried out. Once the testing procedures are standardized, the CEN will introduce directives on safety requirements for all household textiles by taking into account the environmental issues (chemicals utilized to make fabrics flame retardant could have adverse effects on the environment).

Imports from third countries are subject to rules (92/C 329/03) on product safety. The proposal states that products should not be put on the market unless they conform to the rules applicable and that individual member states are responsible for carrying out related checks. If customs authorities find that the goods could pose risks to health and safety, that documents which should accompany the product or batch of products are missing, or that the product is not marked in accordance with the Community or national rules on product safety applicable in the State in which release for free circulation is being sought, they will suspend the release of the goods and notify the national authority responsible for monitoring the market.

There is a growing awareness of the need for environmental protection in Europe. Waste disposal is considered one of the major problems and is associated with the packaging materials used by the textile industry. It is therefore extremely important for the exporters of textiles to be aware of the different eco-packaging policies being adopted and their trade implications.

As fabrics for curtains are normally imported in bulk, in the form of rolls, the packaging is generally waterproof, should be able to keep out odours and mites and should be recyclable. Suppliers are however advised to contact importers on the methods of packing preferred in the country of import.

Ready-made curtains are generally packed in plastic bags, either individually or in sets according to size. The articles must be labelled with information on the material, size, colour and washing instructions. Cartons, with colour printed cards on the exterior, a white board on the interior and cellophane-covered window cut into the front of the box is sometimes used. The box must include proper labelling and product description.

7.2 Tariffs

The EU applies the Common Customs Tariff to imports from non-EU sources. The MFN rate is between 6.9% and 12%. Table 4 gives the duty rates for the European Union. Imports from developing countries are regulated by the following conventions:

- ***Agreement on Textiles and Clothing (ATC)***: Following the conclusion of the Uruguay Round, the Multi-Fibre Arrangement (MFA) was replaced by the ATC which will last for a transitional period of ten years ending on 31.12.2004. According to the ATC, the quotas in international textiles and clothing trade are to be terminated, unless the member countries can justify them under the safeguard clause covered by the Agreement. In January 2005, the sector will be integrated into the rules of GATT and although tariffs on such products will remain, they are to be reduced progressively.

The ATC also provides rules and procedures regarding the circumvention of the restrictions through transhipment, rerouting as well as false declaration of origin.

- **New Generalized System of Preferences (GSP):** The new GSP scheme is based on two underlying principles - graduation and incentives. In the case of graduation, tariff advantages will vary according to the sensitivity of the product and the degree of competitiveness of the exporting country. Textiles are considered to be very sensitive products, for which the GSP rate is 85% of the MFN rate (15% of the preferential margin). In the case of incentives, recipient countries that are able to prove a commitment to international standards of social progress and environmental protection will benefit from additional tariff reductions by way of an incentive.

It should be noted that as of 1 January 1998, imports of textiles and clothing from China, Hong Kong and South Korea, textile imports from India and Pakistan and imports of clothing and made-up items from Macau, Malaysia and Thailand do not benefit from the GSP scheme. From 1997, GSP was also withdrawn from Myanmar. The special provision for the Least Developed Countries allows for the total exemption of duty for industrial products. The **Lomé Convention**, which is an agreement between the EU and the ACP countries, allows duty-free and quota-free imports of textiles from the signatories of the Convention. Bolivia, Colombia, Ecuador, Peru and Venezuela also enjoy duty-free entry into the EU. There also exist several bilateral trade agreements between the EU and EFTA and EU and CEFTA.

In order to benefit from preferential rates, goods must be accompanied by a certificate of origin. This document is generally issued by an authority in the exporting country certifying that the goods have been produced in that particular country. The country of origin is particularly important in the case of Outward Processing Trade (OPT) as the goods that are re-imported are subject to the appropriate tariff on the foreign value-added only.

7.3 Promotion

Trade fairs remain one of the most effective means of promotion in the household textiles and furnishings sector. The HEIMTEXIL trade fair that takes place annually in Germany is considered the world's most important international trade fair for home and household textiles, finished products and fabrics. Manufacturers/exporters are encouraged to participate in these fairs as they offer an excellent opportunity for exposure. Annex IV gives a list of some trade fairs and their organizers.

Advertising in trade and other specialized journals (a list of which can be found in Annex IV) is another important method of promotion in the textile sector.

8. MARKET PROSPECTS

The EU continues to be the world's largest market for textiles. Until recently, imports from developing countries had been restricted for several years by a system of quotas under the Multi-Fibre Arrangement (MFA). However, with the incorporation of the ATC in 1995, imports were expected to increase as a result of the elimination of quota restrictions on certain products and the enlargement of remaining quotas in 1995 and 1996. However, the impact so far has been negligible.

During 1996, domestic demand grew in Western Europe therefore increasing capacity utilization. In addition, growth in economic activity led to a rise in wages and higher employment. Lifestyles have changed and people want to keep up with the latest trends and are willing to spend more on home interiors. In 1997, EU imports amounted to 21,541 tons (valued at ECU 194 million), which is a 48% increase (in terms of quantity) from 1996. The home furnishings industry is in rapid development. Fashion trends seem to be playing a more important role in people's choice and natural fibres are coming back despite the tedious procedures involved in maintaining these fabrics.

European demand for textiles can be satisfied from domestic and imported sources. In recent years, EU production has decreased and despite a slight revival in the levels of production, imports continued to grow. Further, steady reduction in import prices and the massive devaluation of currencies in East and South East Asian countries in 1997 have intensified competition leading to continuous growth in imports. In addition, these countries, that are important suppliers to the EU, are likely to gain price competitiveness as a result of devaluation.

Sources indicate that the three principal groups of suppliers to the EU will continue to be Asia (China, India, Bangladesh and Indonesia), Mediterranean countries of Turkey, Tunisia and Morocco and, Central and East European suppliers like Poland and Romania. However, importing countries are constantly looking for new suppliers who are able to provide good quality and cheap fabrics. In order to be competitive, new exporters are encouraged to pay attention to delivery schedules, fashion trends and in case of ready-made curtains, to the packaging; attractive packaging is a must in the retail sector.
